### Background

Prevention of Blindness Society of Metropolitan Washington (POB) is a nonprofit dedicated to improving and preserving sight and quality of life by providing services and education and championing healthy vision and innovation to everyone in DC, Northern Virginia, and Maryland's Montgomery and Prince George's Counties.

We began in 1936 as a 7- point community vision health plan. May Vories, a dedicated advocate for people with vision challenges, collaborated with William H. Wilmer, the founding director of the nation's first university eye hospital, the Wilmer Eye Institute at Johns Hopkins Medicine, to launch the program. Over 85 years, POB has become a leading partner in eye education and support in the DC region.

We reach 13,000 people annually. Our goal is to prevent the needless loss of sight and preserve and maximize remaining sight for people with impairments. Current initiatives include:

- Bright Eyes Program screens preschoolers for blinding eye conditions at no cost and helps families needing further care to navigate a complex medical system.
- Glasses4Scholars Program offers vision screening and, as needed, eye exams and eyeglasses to grade-school children in under-served communities at no cost.

- Affordable Adult Eyeglasses Program is an immediate intervention offering disadvantaged adults affordable eyeglasses, including frames.
- The Glaucoma Program offers free screening and linkages to treatment for people disproportionately affected by this blinding condition.
- Our Low Vision Support Program provides vision rehabilitation, free resource navigation, assistive technology training, and access to an extensive group of supportive peers for people with chronic vision loss.

Project/Program Title: Free Eyeglasses for People Experiencing Homelessness

#### Statement of Need

According to the Metropolitan Washington Council of Governments, there are approximately 7,605 unsheltered individuals across the DC metro area. Further, a 2010 American Journal of Public Health study found that 41% of people experiencing homelessness have a vision impairment, and 56% have an unmet need for eyeglasses. This means that 3,126 of our unsheltered neighbors have vision challenges, and more than 4,200 do not have the eyeglasses they need.

Loss of sight endangers lives by increasing comorbidities, threatening personal safety, and decreasing overall life satisfaction. Additionally, vision loss jeopardizes personal potential and reduces opportunities to reach and sustain self-reliance.

Even when care is available, people experiencing homelessness face significant barriers to meaningful eye care, including prohibitive treatment costs, limited transportation options, lack of identification, unpredictable living situations, and lack of health insurance.

Through the Free Eyeglasses for People Experiencing Homelessness Program, POB and So Others Might Eat (SOME), a nonprofit that helps unsheltered people around the DC region - will partner to ensure that unsheltered individuals receive prescription and reading eyeglasses. Our goal is to equip unsheltered people with the tool of corrected vision so that they can persist on the path to economic self-sufficiency.

The program meets an urgent need in our community. During the past program year, we exceeded our program participation target by 337%. Further, reports indicate that failure to receive timely services results in more severe and persistent conditions, which require more extensive and expensive interventions later – ultimately imposing greater direct and indirect costs on individuals.

### Detailed Project/Program Description

Free Eyeglasses for People Experiencing Homelessness Program is a formal collaboration between POB and SOME that started in 2019. Our goal is to equip people with corrected vision as an extra tool on their journey to self-reliance. Together, we have served close to 300 people.

Through the initiative, SOME provides eye exams and diagnoses, while POB meets the need for eyeglasses. POB holds an eyeglasses clinic at SOME premises every Wednesday. Our optician meets clients, discusses their prescription eye care needs, and helps them select suitable frames. The optician then measures and fits eyeglasses, works

with vendors to process orders and distributes filled prescriptions. The optician also remains on hand to adjust frames and help with minor repairs.

POB carefully customizes eyeglasses to ensure they cater to individual needs, preferences, and vision prescriptions. Furthermore, we are dedicated to providing efficient and timely service, guaranteeing that clients receive their filled eyeglass prescriptions within three weeks.

The clinic will benefit approximately 150 people facing homelessness in DC. By providing free, full-cycle services from screening to eyeglasses acquisition in a central location for a harder-to-reach population, the program knocks down barriers to care among individuals who would otherwise have to delay or forgo care as they prioritize meeting other more urgent needs such as food and shelter. Beyond the gift of proper sight, improved vision is critical in unlocking new opportunities, fostering economic self-sufficiency, and promoting a brighter future for the people we serve.

### **Evaluation and Sustainability**

POB collects qualitative and quantitative data using sign-up and sign-in sheets, phone records, and feedback surveys. POB and SOME also have frequent conversations to identify areas of improvement to ensure our clients receive a lasting impact. Further, we utilize client interactions and informal discussions with program participants to streamline and improve program delivery. Data tracked includes:

- a) Program reach POB maintains a monthly record of the number of program participants receiving services. We anticipate serving 150 SOME clients during the funding period.
- b) Services provided POB monitors the types of glasses most requested to help us plan for future needs. We use intake forms and follow-up services to track clients receiving prescriptions and reading eyeglasses. All data is saved to an encrypted client database management system.
- d) Client satisfaction via feedback surveys POB encourages all program participants to provide feedback through informal conversations to improve service delivery. POB and SOME rely on philanthropic support from public and private sources. Both organizations remain committed to meeting the eye healthcare needs of people experiencing homelessness through the Free Eyeglasses for Individuals Experiencing Homelessness Program.
